Discussion revise dog ordinance and fines

With this information the dog ordinance will need to be reviewed with the updated ordinance has been found. You need to get proof this took place before killing the dog for law enforcement to verify. Without this proof you will go to jail.

Rex will call and talk to Coldwater, B. Jackson or Parsons about getting a grinder out here to remove the asphalt, grind it down to a fine material that we can spread and will stay in place better.
